- (b) Proposals for additions or alterations to the Constitution (which must be proposed by one Member<sup>1</sup> and seconded by another Member) have to be sent in writing so as to reach County Secretary by 30<sup>th</sup> of April,
- (c) Under the Regulations duly passed since the 2007 AGM, details of any other relevant matter for the consideration of the Committee during the ensuing year must be submitted in writing to County Secretary beforehand and not less than 48 hours before the time for which the AGM has been convened.
- 2. The provisions of the Co-operative and Community Benefit Societies Act, 2014 would oblige us to appoint qualified auditors (which would represent an inordinate expense for us) each year; but the Act also allows for this requirement to be dispensed with in the following circumstances: -
  - (a) Where the assets and turnover of the organisation are below certain levels<sup>2</sup>;
  - (b) Where the Constitution so allows (which ours does) and;
  - (c) Where the appropriate Resolution is passed at the AGM (provided that less than 20% of votes at the AGM are cast against the resolution and that less than 10% of the membership votes against the resolution.

#### **REPORTS**

### **RFU Council Member**

This season has been a very busy one, in any role if you are going to give it your best shot you have to put in the time attending meetings, listening to views and so on. Also, it is important to get out and about around our clubs and give support where possible, including our Representative sides. The result is hours of driving, as our Twin counites do not always have the best of roads!

Can I thank all the clubs visited for their warm welcome and hospitality- it is always a pleasure to visit our clubs within the Twin Counites and listen to their viewpoint.

As ever, watching games across the different league levels, both male & female, it is encouraging to see so many players running around enjoying the game. These games can be Friday night, Saturday afternoon or Sunday morning and afternoon. I would like to thank all the players, coaches, team managers and volunteers in our game for their efforts in the last 12 months, all working hard to ensure this wonderful game continues to thrive.

On that note it is pleasing to report that the match completion rate has improved in the Adult Male game with playing numbers heading back towards pre-covid levels. In Age grade there is also a slight increase in numbers playing whilst the Ladies game seems to have levelled off a bit. However, we have the RWC 2025 coming next summer and hopefully that will give a big boost to the Women's & Girls game and playing numbers.

One area there was concern this time last year was around the new tackle height laws and the impact it was going to have on the game. It is pleasing to report there has been no evidence of a drop off in playing numbers as some feared, if anything the playing numbers have gone up. The number of head injuries has stabilised and the fear of an excess of red cards did not materialize.

Continued monitoring around head injuries and injuries in general continues. World Rugby are due to look at Tackle height in the top end of the game later this year. They will be looking at data obtained from the RFU, NZ union, France and others.

As reported elsewhere, the Representative sides have given it their best shot again this season.

Highlight has to be the U20's reaching the final at Twickenham in June and it was a pleasure to see the team run out at the home of English Rugby. Sadly we lost in the last 2 minutes of what was a compelling game- well done to everyone involved. The Senior Men's team had similar back luck in their semi-final away to North Midlands, losing by a point with the last kick of the game. The Ladies team acquitted themselves well against strong opponents and credit should be taken from losing in the pool narrowly to Devon, who went on to win the Competition comfortably in the final. For all players who pull on a County shirt the experience is something that will live with them for ever.

As well as attending RFU Council meetings, I am on the Adult Competition Management sub-committee. As well as overseeing the leagues, ACMSC also has oversight of the RFU Cup (Papa John's), Ladies Leagues and Cup and regulations around the game. We also undertook the first review of the Future competitions Structure, which is due a review every 3 years because whilst we have only had 2 years of the new structure, any changes to be made need to be given 12 months' notice.

I have also been part of the oversight group keeping an eye on the Adult Player Registration process, as well as an oversight group dealing with re-writing and ordering of Reg 19- Discipline.

Nationally, it is good to see the fortunes of the England Men's team pick up as last season went on. It has also been great to see the success of the Red Roses and hopefully this set up the team well for RWC2025. The U20's has also enjoyed success this season and shows there is a pathway to the National team, hopefully the future National sides in both the Female & Male games looks rosie.

Linked to this success is the new Professional Game Partnership that is being put in place for the start of next season. This should give the England teams better access to the players but also to their playing data, injury management, game exposure and so on. Linked to this is the new 2<sup>nd</sup> tier (Championship) which all being well should help to provide more game time to the up and coming younger English stars of the future. You may read in the Press about the Championship clubs wanting more money, just one word of caution, there is a pot of money and if more goes to the Championship then there may be less for the community game!

The other area you may have seen mentioned is around Community Game Future. Work on this has continued in the last 12 months with the proposals to be moved forward early next season.

The 4 focus areas are:-

- Running rugby
- In the Game
- On the Pitch
- In the clubhouse.

Some of this is likely to be devolved to local levels- more details are awaited.

I hope the clubs have found the notes sent around post Council meetings of benefit, I plan on continuing doing these, in conjunction with a couple of my fellow Council member's next season.

Finally I just wanted to end saying it's been a pleasure representing Dorset & Wilts clubs again this season, thank you for re-electing me to continue this role. I will continue to do this to the best of my ability. As ever, I am at the end of the phone or e-mail should you ever need to raise any issues or have any questions.

Enjoy the rest of the summer and I look forward to seeing you during the coming season.

#### **Community Rugby**

Once again, the league seasons were affected by weather conditions, with several clubs having a build-up of fixtures resulting in playing back-to-back weekends for a considerable time. Despite this I am pleased to say that the Dorset and Wilts leagues concluded as per the schedule and the details of this can be found below.

Keeping a watchful eye on proceedings were the Dorset & Wilts Competitions Committee who met on a regular basis, not only to maintain a perspective on the league situation from the league secretaries, but also to formulate cup competitions for those teams who would not be eligible for the national Papa John Cup. As was the case with the leagues, we fulfilled our objective to offer a meaningful cup competition across Counties 2 and 3. Details of the 4 finals can be seen below.

As mentioned, the season had its challenges, but they were overcome. Below is an overview of leagues and how they look in the 23/24 season, followed by a summary of this season's leagues/cups

#### **Leagues**

**Levels 5 – 7 (Regional 1 & 2, Counties 1)**: Dorset & Wilts have 2 teams competing at Regional 1 next season, Royal Wootton Basset and Marlborough, both of whom will play in Regional 1 South West. Of our clubs competing at Regional 2, 3 are playing in the London & SE Division, Bournemouth, Wimborne and newly promoted North Dorset. The remaining 3 clubs that will play at R2, Chippenham, Swindon and Trowbridge will all play in R2 Severn.

C1SS holds all our L7 clubs, with D&W occupying 9 of the 12 places in the league. Coming down from R2 are Salisbury with Chippenham II and Melksham moving up from Counties 2. This will be the first time that Chippenham II have competed at this level and a return to L7 rugby for Melksham after a 12-year absence.

Levels 8 – 9 (Counties 2 & 3): We have continued with the 3 way, North, Central, South split with our leagues at these levels and the reduced travel this brings seems to be welcomed by clubs and enables greater fulfilment of the playing calendar.

The 3 Counties 2 leagues have been increased to 10 teams, giving a playing season of 18 games. It is felt that this will improve the competitiveness of the leagues and that the extra games will help the teams who are promoted at the end of the season in their preparation for a 22-game season at Counties 1. In Counties 3 the North and Central leagues have 6 teams playing each other 3 times i.e. 15 games. Teams in these leagues will be encouraged to seek friendly games in their break weekends, with league secretaries being on hand to assist in this where possible. C3DWS continues as a 9-team league and will feature 16 games.

The league season will start on 7th September for R1, R2, C1 & C3DWS. C3DWN/C will start on 21<sup>st</sup> September, with a league season end date of 5th April 2025.

League Winners 2024-24: R2S saw Royal Wootton Bassett make a quick return to L5 with the best points differential of any team at this level nationally. C1SS saw North Dorset achieve their 2<sup>nd</sup> promotion is 3 seasons. The Counties 2 D&W leagues produced 3 champions, C2DWN Chippenham II, C2DWC Melksham and C2DWS Lytchett Minster. From these 3 leagues only 2 could be promoted and a play-off between Chippenham II and Lytchett Minster resulted in Chippenham winning an epic encounter at Allington Field to join Melksham in Counties 1 Southern South next year. In Counties 3 Fairford won C3DWN, Bradford On Avon won C3DWC, and Swanage & Wareham II were victorious in C3DWS. The league winners were recognised and awarded their shields at a St Austell Brewery; Tribute sponsored evening on 14th June.

#### **Cup Competitions**

Despite some issues throw up by the RFU's decision to change non playing weekends and to also extend the season past 6<sup>th</sup> April if games were deemed relevant to league positions, we successfully completed our Counties Cup/Plate finals within our timeframes. Thanks to both Chris Jones and Mike Moysey as competition administrators for all their hard work in successfully delivering this season's competitions.

#### **Record Keeping**

Constituent Bodies must ensure that they have a record, available to the RFU when requested, of all Incoming and Outgoing Tours (including Home Union cross border matches) arranged by their clubs during the season. Where the Constituent Body has provided its clubs with pre-approval for matches, as permitted by RFU Regulations 10.5 or 10.6, then at the end of the season the Constituent Body must collect from the relevant clubs the following information for each match:

- a) Name of RFU Club
- b) Date of Match
- c) Venue (Home or Away)
- d) Name of Opponent's Club and which Union it is a member of
- e) Details of teams involved (1st XV men, 2nd XV Women, U16s boys etc)
- f) Result

Any player or individual serving a Disciplary Sanction will not be permitted to participate in or to travel on any tour.

All documentation requested to be submitted to the D&W RFU by the deadlines set out above, any failure to do so could result in one of the following actions to be instigated.

- 1. Any existing tour approval to be withdrawn.
- 2. Disciplinary action again the Club and/or the Tour Management.

Any club has the right to apply to the RFU for consent to be involved in a tour if they so wish.

## Women Rugby - No report filed

### **Girls Rugby**

The Girls U16 ERDPP has been taken in-house by the RFU and renamed the Players Development Group this will cover Girls under U18 and U16 age groups.

Girls U16 is the Foundation Phase, our CB will now be D&W's Girls U16 PDGFP and we will have two centres for the 24/25 season, one at Dorchester RFC and the other at Melksham RFC.

Two assessments days are planned for each centre, one on 19th August and the other 02nd September. Details of how to nominate players have been circulated to clubs and schools.

The last year has been very busy with in particular the change over of the U16 & U18 systems.

A number of the older U16 girls were put forward at the end of the season to the new U18 PDG now run by the RFU.

The U16 girls now known as the PDG FP (previously ERDPP) has seen over 100 girls apply this autumn to participate in the programme. Initially 22 have been selected for the Melksham Centre and 32 for the Dorchester Centre. The majority of the rest have been ask to 'Call Back', in November. The programme emphasis is on inclusion and personnel development.

The U18 put forward players at the end of the season to the U18 PDG which is now in operation.

Sunday 10/11/24 – development day

- > Some clubs run their warmups on Sunday mornings, with all girls together which they find beneficial for retention through the age groups.
- A session/ day at the club for all females (women's teams all the way down to minis) to ensure that girls feel they can stay in the game - this is run by some clubs, who receive positive feedback on the event.

We'll use contacts on GMS to contact clubs - please ensure your Girls' Leads and Youth Leads are up to date.

The forums are supported by Olivia Jenkins from the RFU.

The season has started off with lots of girl's rugby and we look forward to a very busy time.

#### Governance

#### Safeguarding

#### 23/24 Activity

14 Play It safe courses delivered across the region. Julie Fisher has been externally assessed twice in the last 12 months and has been approved to continue to deliver the course. Courses are being booked for August onwards with tutors from neighbouring regions being used to deliver courses to the far North West of the area, this is due to the time it takes to travel to those areas, deliver the course and return home.

106 17-year-olds have been assessed by coaches with forms submitted for them to play adult rugby. These are now submitted electronically allowing me to be able to check the details and approve or reject within a matter of days with the RFU holding a central document on our behalf. This is cross checked against any 17-year-old that has been registered in an adult game, we have not noticed any 17 yr. olds playing without approval so the process is working well. Going forward these will not be approved past Thursday lunch time, this is to ensure the club is able to get the player registered as an adult in time.

Late applications for Out of Country tours or incoming teams are continuing to be received. The normal safeguarding process still needs to be followed even if the approval paperwork is being worked on by Gerald as the CB need to apply to the external Governing body for permission, so this is managed by the Secretary. Reminder of the process to be sent to all clubs before the start of the season as several tours were very last minute which didn't give any time for in depth checking.

Festival applications are continuing to come in, these are assessed by Joe Walsh and approved as needed. These will be on a SharePoint document for 24/25 season.

In England Tour notifications are again coming in and assessed by myself for safeguarding concerns at the club then as needed are approved by Joe. I am looking to see if the RFU will enable this to be done using the SharePoint portal for next year. This process was discussed at the CBSM conference, and a focus group is to be formed to pull the info together. Multiple other CB require all crosscounty festival attendances to be approved so we need to decide if this is something we need in D&W.

Playing up or down applications are managed by Joe Walsh, again these are now submitted electronically allowing us to maintain a SharePoint log of these. We need to be aware of cross-checking combining age groups against GMS as

there are some clubs who applied to combine but had enough players to maintain an age group on GMS.

8 deep dive Audits have been completed this year with follow ups from several clubs who had audits last year. The plan for 24/25 Audits is being drawn up now. Bradford on Avon, Chippenham, Swindon, Trowbridge are all on the list following incidents this year.

We have not managed to hold a CSO conference this year, when discussing with CSO there appears to be an issue with when the majority could attend. This is to be prioritised for later in the year.

CSO calls are now being held on teams, these are still not attended by all clubs, often we have 20+ say they will attend but on the day, it is the same people who log in.

Calls and emails are continuing to be received for advice and referrals to the RFU. These are managed and passed upwards for RFU to look at and assess further needs for the family involved.

Coaches who have applied for DBS and have information needing explanation are continuing to fail to provide this in time so are excluded from rugby until such time as they resubmit and provide the evidence needed for the DMG to assess risk.

The RFU CB Audit was held, and the results were sent over. This highlighted several areas for improvement, mainly around notifications for U18 Red cards as these are not being notified to me at all. Request to be copied in when requesting further information from the club following a red card so I can ensure the CSO is able to support the child throughout the case. Concerns were also raised directly to me about Junior discipline cases being held late at night, can we look to hold these at the start of the evening going forward please.

The CBSM and Assistant attended the CBSM Conference at Teddington. Updates for proposals for tours discussed. Self-audit to be completed by October. Most other areas require notification for cross county fixtures but being notified that the club is attending a cross-county festival is enough at present.

STAR charity information was shared at the conference, this supports children from deprived areas to attend rugby clubs, providing kit and travel etc for these children so we need to look into which clubs across the region would be willing to be involved in this as it can literally change a child's life.

Travelling across the region to complete deep dive audits is time consuming, especially as I am based at the bottom end of the region, having a trained volunteer in the north who can assist with this would be beneficial. The person needs to complete the volunteer application form and have experience.

I have not been notified of the coaches or manager details for the Age grade representative teams and so am unable to advise if they are DBS compliant or have attended play it safe within the required time. Can this be sorted please?

We discussed last year that officers of the CB need to attend the play it safe course, but I am unaware of any such course being delivered or attended by the officers of the CB. Can I have confirmation that this has happened, or can we book the session?

Communication online between u17 manager and players was requested on a Tweet and Instagram, this was seen by the CBSM, and advice given immediately to remove the tweet. reminder that nobody should be having direct communication with any player under 18. Please form a SPOND group and use that instead.

Volunteer application forms are still not being used across all clubs, this is a vital part of safer recruiting and needs to be completed to provide evidence that the club has completed due diligence in recruitment. If clubs or the CB fail to do this then that leaves the club or CB open to further action if something goes wrong.

Please ensure that the form is fully completed references are checked, DBS is actioned. Then add a note to the GMS record stating Safer recruitment process followed. This has been requested for clubs to adhere to for the last 4 years across D&W.

A reminder that all cases must be reported to the CBSM immediately regardless of how small, the club are not able to investigate any safeguarding concerns unless advised to do so by the RFU team. There have been 5 incidents this year where this didn't happen which then left a bigger case to deal with that meant that a child was left unsupported for an extended period.

A reminder that the club need to notify the CBSM, when the CSO or assistant changes at a club to make sure that the correct details are held and information is shared appropriately. Several clubs have CSO who are not attending the calls or responding to emails/ calls. It is important that they are responding to email requests for information in a timely manner to ensure safeguarding guidelines are maintained. If the CSO is unable to attend the calls then a representative should attend on their behalf.

Full start to finish process for all Tours to be updated and provided to clubs before start of season.

Plan a CSO update session/ Conference

#### Rugby Safe

Our region has made great strides with Rugbysafe with every playing club having a named Rugbysafe lead, and the risk assessments and first aider requirements as mandated in Regulation 9. There is still some work to be done to ensure this information is kept up to date as club RSLs leave and are not necessarily replaced before the start of the next season.

CRISP - as a region we are not showing much commitment to the Community Rugby Injury Surveillance & Prevention programme with only 2 clubs and three teams reporting. This initiative is vital to the ongoing safety and injury monitoring of the RFU and I will be asking clubs to participate if they are able. Clubs that do participate will have a year's subscription to ProActive paid for by the RFU in the following season.

Proactive is gaining traction with more teams subscribing and benefitting from having everything in one place. Proactive have now launched the concussion tracking module which monitors a players GRAS protocol and provides automatic updates to both the player and the club.

There is a move by the RFU to ensure that all clubs are compliant with regulation 9 before the end of the year and I am sure all our clubs will be compliant.

We have had some issues in the region booking First Aid courses, but we have a new tutor for the region who is keen to get courses on the books. He has, however, been hampered by clubs booking courses which are then cancelled at the late minute as the club cannot get enough attendees. We need to establish more discussion between local clubs to help each other getting these courses fully booked to avoid future cancellations.

All in all the region is in a significantly better place than it was 12-24 months ago, and the upward trajectory is continuing.

If a club complies with the RFU Regulations within the 48-hour period, the fee will be reduced to £85.00.

#### **AREA REPERSENTATIVES**

#### Area Leads - Council Members (Elected)

Currently at 5 areas, 3 Wiltshire, 2 Dorset. We have a project in place to change the way the areas are made up, Dorset will remain as is, but Wiltshire will be split into 2 10 club areas, North and South, having a lead for each and a coordinating council member sitting over all 4 areas as a reporting point and mentor. We have a requirement for these positions in Wiltshire to be filled. We have had one co-opted member this season taking on East Dorset who will stand for election at this AGM. The Representatives are the link between the clubs and the CB, Reps will visit clubs when requested and will hold area meetings 3 or 4 times a season to allow sharing of views and ideas and the dissemination of information from RFU and CB to the clubs and comments and requests from clubs to CB. The reps are also the clubs point of contact for any issues they have.

This season has seen meetings in West Dorset and the old S Wiltshire taking place, but the other clubs have not been represented as well as we would have liked. It is my intention that over the upcoming season this will be rectified and meetings held, either in person of via Zoom, to ensure we have good contact withing clubs. It must be emphasised that the meetings are not just for club executive members to attend, a club can bring along anyone along who needs to have an involvement in facilities, playing (any form), Grounds, Fixtures, regulation, safeguarding welfare or anything. While we have a set agenda, clubs can add other items if they want to discuss, it's an open forum and can be "Chatham House Rules" if needed.

We as Council look for club people to stand up to be on Council and help deliver Rugby in Dorset and Wiltshire, please contact me in interested.

### **GMS**

As Data Officer for Dorset & Wilts I carry an oversight of clubs GMS within the CB as well as our own. To that end I am a little disappointed to find that many clubs are still carrying people records which are either no longer with the club or are incomplete or carrying email addresses that are duplicated, unverified or missing. As we move into a new era where players undertake their registration this has to be sorted otherwise clubs will find that they have unregistered players for next season. We now have a 2-tier system for below Level 8 men (C2)/Level 5 Women (NC2) where players only need to be club registered and can be registered with more than 1 club – and they control that themselves. It therefore is vital that all players access their GMS accounts and complete the actions required. As an RFU trainer I can help clubs and there are YouTube recordings of Players and Club seminars on what this involves – it is very simple and is almost as per Age Grade.

#### Walking Rugby

Once again, this year I stood as lead for Walking Rugby in D&W. This is a coordinating role and encourages participation by clubs in D&W

At the end of the previous season we had 4 active clubs, we now have 14, which is absolutely brilliant, however only 1 of those clubs is in Dorset, therefore my push this year is for more take up in Dorset (Wimborne are out on a limb)

I ran a Festival/Tournament again this season (Walking Rugby "season" is March to October, although most clubs offer some rugby in the winter as well – some inside) This was won again by Chippenham in a Final against Salisbury again. Toi that end it has been decided to move away from a tournament structure next season (29 March 2025) to a less structured festival where fair play is the name of the game, Clubs can keep scores if they wish but there will be no finals played and the winner on points awarded by referees in each game. I am hoping we can get at least 16 teams participating by then.

Talking of Referees, we do have a Referee trainer located at Amesbury who is happy to train any club referees, please contact me and I will put you in touch with Roy. I am hoping that some of the Referee Society folk who are looking to step back from the full game will join our band of Walking Rugby Referees in the future.

#### Referees

The season for capturing appointments runs from 1st Aug 2023 until 31st May 2024, this covers most of the season, although some county fixtures went beyond this point. we were asked to provide 1028 match officials as either Referees or Assistant Referees compared to 1058 the previous season.

We appointed in total 958 Officials during this season with a breakdown can be seen below in Table 1.

As with previous seasons the appointments covered every day of the week, with clubs branching out from the traditional Saturday and Sunday.

As you can see most of our games were at L8 and L9 and still adult games; but the more positive note compared to last season, is the dramatic drop-in games we could not fill, only 70 this season compared to 211 for the season 2022/23.

This reduction in unappointed games is a credit to the society's members for coming forward, when the appointers asked for volunteers.

As per last season, the relationship with Bath Academy has moved forward, with not only officials supporting NLMOT Referees for the Prem Academy games but providing full Teams of Three for the U17 fixtures.

This season, saw changes in how the RFU appointed to the Papa John's at R1 and the end of season county fixtures at Senior Men's, Ladies and U20's with more fixtures delegated to society's rather than the Regional Match Official Teams.

Also, a first for Dorset & Wilts, with a voice on the Bath Combination Committee, the society was invited to provide officials for the Bath Combination Vase Final, that was played at the Rec on the 8<sup>th</sup> of May.

Looking forward to this season when we hope to run club referee courses to try and reduce the number of non-appointed games. The courses will be for about 3 hours in an evening, and on successful completion of the course (subject to RFU funding being available), candidates will receive an Acme whistle and lanyard and a reversible bid, with the words "Club Referee" on. By attempting to generate more grass roots referees we hope that we can bring down the total number of unappointed games considerably, by allowing clubs to use their trained club referees when the society is not in a position to appoint. More details will be promulgated once funding is confirmed.
