I have had another S Wilts meeting in this period. No formal reports through from any area reps but I have had a WhatsApp note from N Wilts which is included.

Following the project we have now set up as 2 areas in Dorset (East and West), and 2 in Wiltshire (North and South) We had all 4 positions elected but unfortunately Brendon has had to stand down owing to family issues, so we actively are seeking to recruit someone from the area to take on this role as I cannot cover that and the lead. Still only S Wilts has met as a huddle which I chaired in absence of a post holder. N Wilts has been active in trying to make contact with clubs, but they have not been responsive particularly responsive, but some have fed comments back to Chris which are included below. We have sent out to the E Dorset group of clubs and heard back from Poole and Wimborne only. Given that it is our intention to set a date and issue a zoom call invite, if clubs turn up all well and good.

I will hopefully hear from Ed on progress in W Dorset soon, I am aware that Business has interfered with his usual activity.

Please see my elements of Data in Governance report as that is something I need the Area Reps to impress on clubs that they must keep clear.

Comments provided by N Wilts rep: (My comments in Italics)

- Concerns mentioned by some clubs about RFU support to *Grassroots Is this perceived or is this clubs not contacting or following up with Club Developer? Ben has set up a number of club vests (virtual and in person)with clubs in D&W. Ben attends Huddle meetings so perhaps that is the issue with clubs not engaging with Area Rep?*
- Ongoing issues with club player registration (but I suspect is in your reports) I need to follow this up as I am not sure what this is, as GMS trainer they have not been reported to me
- Not much come out so far promoting Ladies RWC (unless I have missed comms, but I haven't seen anything on it across clubs within 3 CBs RFU should be doing more)
- As said in last CB meeting; clubs need to take more advantage of grants/funds and sponsorships with specific reference to those wishing to support the promotion of Girls and Womens Rugby. (But this has been covered but don't think there has been much uptake from clubs I've had contact with) there is a proposed solution, but clubs have to engage!!

If you have Under 18s on pitch in seniors, make ref aware – naturally these will be properly approved and on match cards.

Dorking U11s festival/match 23 March – anyone interested? Ref Societies – please confirm kick off time in week before.

Pewsey provided an update covering their club aspects:

The section continues to progress with approximately 40 children registered. Despite the poor weather only 1 training session has been missed this season. The Club has 4 qualified coaches and 2 support coaches and runs age groups up to under 11's. The coaches have completed one outreach program of 6 weeks at Woodborough school prior to Christmas and are now running a second program of 5 weeks at Pewsey Primary school. The club is hoping to meet with Amesbury minis in the next few weeks in order to see if there are possible joint developments which can take place. The club had upcoming fixtures (home and away) with Swindon coming in February and March.

Since the start of the 24/25 season the section has been awarded a grant of £800 from WASSP and has also received further donations of £500. This money has been used to purchase kit and equipment

(Note to others WASSP do provide grants for Wiltshire clubs, be worth contacting Pewsey for details and/or Alan Low at RWB as he is something to do with WASSP)

If I missed anything I apologise, as you could tell last evening I wasn't on top form, hoping Brendon will be able to take over soon.

4. Governance – Jane Hart (TBC)

Safeguarding – Julie Fisher

Previous month's activity:

- 1. 17 yr old playing adult rugby continue to be submitted across the county. Some have been submitted with very poor assessments having been completed. These have been rejected, and assessments have been requested, a template for assessments has been again provided to all clubs. There have also been a couple of occasions where the referee or other team have not been advised before the game that a 17-yr old is in the squad. No reports of any issues with these 17 yr olds have been reported. A reminder about 17 yr olds not being signed off before being named on a team sheet was issued today, I am glad to state that I have had confirmation that not one 17-year-old from D&W is on the list of not being approved in advance.
- Playing up and down approvals are being submitted, some for clubs where there are not enough within an age group to fulfil a team. Players are being assessed appropriately and where they have not, we are referring back to the club for a fuller assessment.
- 3. Tour approvals are being submitted. There have been a few where the forms are being submitted by a parent who is taking on the tour organisation, this means that there have been gaps in the process. Clubs are reminded that the process is all Outgoing or ingoing tours must be submitted to the Hon Sec 8 weeks before the date of the trip, with the risk assessment and safeguarding approval coming to the safeguarding team. There have been a couple of occasions where the safeguarding team have forwarded the information to the hon sec but have had no response to say that it is being worked on. The safeguarding team are holding comprehensive records for each tour. I would like to set up a smartsheet form that is held in the shared drive so that both the Hon Sec and the Safeguarding team can keep a clear line of sight for all tours. A recent match had to be cancelled as the appropriate paperwork had not been submitted to the WRU from the incoming club, this has an effect on the players and the club so finding a better way to manage the permission process is needed. I am in discussion with the RFU team following the conference where we had discussed the challenges many areas face. Clubs are to be reminded that we require a short report on completion of the tour, a form is being drafted that will capture the information.

The statement about a tour not going ahead is incorrect, the tour was approved once the paperwork was submitted to the WRU.

The statement regarding the safeguarding team not being informed about tour approval is also wrong, all tours are forwarded to safeguarding@dwrugby.co.uk

The T& C's relating to touring is clear that it is the club's responsibility to inform and supply the requested information to the Safeguarding Team and to obtain consent from other unions.

- 4. Several festival requests have been processed, and approvals been given. One festival has been cancelled due to low numbers. One festival have several teams from Wales attending which will require incoming approval, the host club has been reminded of the need to get these in asap.
- 5. I used the records within GMS to email all of the named CSO and CSA, many have not responded, which leads me to be concerned that they are not managing any potential safeguarding referrals. I have scheduled a Teams call for Monday and have requested at least one person from each club to attend. I have discovered that several clubs have changed their safeguarding team members but have not informed the CB Safeguarding team, they have been reminded that this is an important part of the process as we need to manage expectations and ensure that training is provided appropriately. There are also people in GMS holding positions that they no longer hold, this needs to be cleaned up by the clubs.
- 6. I have made contact with the Dorset and Wiltshire Sports Welfare officers and will be working with them to access any relevant courses and information that will benefit the safeguarding officers or any other volunteers. I am hoping that this may support an update session for all the safeguarding teams.
- 7. All clubs completed the Safeguarding self-audit, the results have been assessed and a meeting with Viv, Nicola McCombe and me along with one committee member (Hopefully Head of Governance) to discuss any findings that give concern. Dates have been provided to Nicola McCombe and Viv. 3 clubs gave low scores for support given by the CB Safeguarding team but when asked about the reasons for the low score, the explanations did not suggest a low score was needed. Low scores for the RFU Safeguarding team were also given, again when discussed, there was some frustration about how long things take to process when a report goes to the Safeguarding team. Clubs have been reminded that cases need to be fully investigated to ensure all reports are dealt with appropriately.
- 8. There have been 4 Play it safe courses since December with over 76 attendees, with 6 further courses booked across the region. We are waiting for sign off for a new tutor Kirsty Phillips who happens to also be a RFU Safeguarding case manager, this should happen on the 12th of February. I have raised my concerns about the length of time that it is taking to sign off new tutors to cover the north of the region but have had a poor response from Tim Pickard. Hopefully if we can get Kirsty cleared, we will be able to offer more frequent courses for the north of the region. Currently it can take up to 2 hours for me to travel to a course, 3 hours to deliver and 2 hours home again. This is not sustainable especially as the fee for delivering the course is supposed to cover 50 miles, I have asked for a review as the cost of fuel is rising. We are required to give 6 weeks' notice to book a course, this works well as long as the clubs promote the course and volunteers get booked on. We have had several courses where we have barely had 10 attendees, again this doesn't give a great experience for the attendees, so clubs need to be more proactive in supporting people to book and attend.

 Safeguarding audits are continuing in line with the guidelines of 30% of clubs having a deep dive audit. Royal Wooden Bassett completed theirs on the 26th. Bradford on Avon and Trowbridge will be completed this weekend.

	10. I am still not being advised when there are red cards for players who are U18, can I ask that I am copied in from the start, in line with recommendations from the RFU team last year and all other CBSM.
	GB is unaware of this requirement, when reviewing any discipline report it usually clear if there is a Safeguarding issues
	Perhaps a shared folder would be useful to keep an outline of the ongoing cases would be beneficial?
	11. We have had an increase in poor behaviour from both parents and players. Clubs have been reminded that the CB discipline board will deal with incidents of parents entering the field of play or poor behaviour appropriately.
	12. Several clubs are posting full squad lists for youth teams on social media, clubs are reminded that this is to be carefully managed and must be under full permission from parents. Same with photos, several coaches have been posting team photos on their own social media which is not recommended under safeguarding guidelines.
	13. The D&W Committee members do not yet appear to have attended the play it safe course that was suggested to ensure that everyone is aware of their responsibilities regarding safeguarding. Can I please be updated? I can ensure someone else delivers the course if need be? We also need to ensure that the representative coaches/ Managers/ First aiders have current DBs checks and have attended the play it safe within 3 years, again I do not have this information so cannot sign this off as completed.
	Play it Safe for D&W Officers, we are still waiting for a date from Safeguarding
	14. Do we require the Ladies management team to have DBS checks and attend the play it safe? We should in line with guidelines, especially if we have a 17-yr old playing up. Can I be provided with the relevant names to check the system please?
	15. The RFU safeguarding team have this weekend issued a new online referral form, this will provide a better way to get the referral across the desk and also an update process for the CBSM when checking back.
Current Budget update:	No idea as have not been advised of the budget for Safeguarding
	No request received following on from the Council Calling Notice (dated 3 rd December 2024)
Proposed Activity (including estimated cost)	 Explore options for a safeguarding update for CSO's including room hire, speakers etc Exploring costs for some updated Behaviour cards for clubs- have been issuing the angry man cards and the code of conducts but some clubs require more tools to support them.
Items not for publication	1. Ongoing case at Bournemouth- Minor parent and player complaints about behaviour (Mostly stemming from school), team selection and low-grade bullying-being dealt with as an education piece of work. There were a couple of referrals through to the safeguarding team for advice and clarity that the correct process had been followed.
	This is currently being investigated by GB. GB is concern of Julie's involvement in this incident (Standing Orders state that you cannot be involved in matters relating to your own club). Julie texted GB during the week asking a series of leading questions. Once GB became aware of this incident Julie's questions started to make sense.

2. Oaks V Bridport- Parents entered the field of play following an altercation between players, referral sent to safeguarding for review but is to be dealt with under discipline. Oaks have started the process. I have seen that the RFU Team have sent the redacted bundle to the HON sec for action but have not been given any update from the discipline team.

Case passed to D&W Discipline from RFU Safeguarding Team.

New Discipline Officer appointed at Oaks – first contact with him was on the 3rd of February 2025 in which he shared with me the outcome of the club's Internal Discipline hearing.

Course of action suggested to RFU Safeguarding – awaiting reply

3. RWB- poor discipline from players on Sunday- reports being drawn up for review and assessment.

The only Red Card Report/Incident regarding Age Grade at RWB, that I have received was for an Under 18's player. This was rescinded due to the Somerset referee not submitting a Red Card Report.

- 4. Bradford on Avon- Coach reported to have kicked a girl in the back whilst she was laid down on the floor. Following an extensive investigation this has been dealt with as an education piece. BOA are cooperating with a full deep dive audit to see where the process broke down and to put in place processes to prevent a recurrence of this behaviour. 2 Play it safe courses have been run at the club by Rich Berry with a 3rd planned for March. The coach has been advised to complete the play it safe course and will be observed for a period of time. The club will be required to adhere to all recommendations following the audit within a designated timeframe.
- 5. Ongoing case at Oaks- A Women's player has complained about discrimination despite multiple risks due to her own health conditions- currently an EGM is being held on 5th March to review her membership at Oaks as they have rescinded her membership and asked her to leave. This has taken a considerable amount of time to get to this position with several high level RFU staff being dragged into it. This has been poorly handled from the start of the process and caused a considerable amount of work from multiple agencies to get to any resolution.
- 6. North Dorset- Adult ladies' player with multiple health issues has asked to join, the club have asked for clarity and support around a risk assessment for her.
- 7. Trowbridge- Coach has been suspended following an incident where he is reported to have physically dragged boys back into the changing rooms and shouted loud enough that there were several people looking over. Awaiting more information but likely to be dealt with by discipline. Currently with the Safeguarding team- will report back when more details are available.
- 8. Dorchester RFC- Report of U16 using SNUSS (Nicotine chewable) Information sought from the drugs team and the SWO. Education is to be provided to the club as we are unable to do anything about it as it is not illegal.
- 9. Devizes- Parent reported concerns that his ex was breaking a restraining order. Information provided to dad and advised to call the police if it happens.
- 10. Supermarine- Delays on some DBS. Issue with a coach that was referred to the RFU team and I am awaiting further information
- 11. Pewsey Vale- Coach charged with assault, ongoing case. Stepped down immediately from coaching- waiting on update from the RFU Team.

12. North Dorset- complaint received and being dealt with by the club

13. Bournemouth- Adult male who was under a court order to stay away from mother and child discovered where the child was playing rugby and followed them.

Safeguarding procedures put into place in case he attends the club again.

GB stated his concerns that the standard of correctness with in the safeguarding reports is worrying.

Data - Clubs still need to cleanse data to comply with the GDPR (DPA). Clubs (and CB) should not have data accessible of its part of GMS for people no longer associated with the club, so when a child is deregistered and moved off its important to remove parent as well if not connected with the club another way, same for senior ex player and social members.

Its been noticed that some clubs are bloated in numbers which just doesn't look right.

If they need help then https://help.rfu.com/support/solutions and if not sure please come to me and I will help. Finally please ensure your golden roles (and other role holders) are up to date. RFU and CB contact clubs using these, we constantly get asked to remove people from distribution lists, but its clubs not keeping GMS updated that is the issue, not CB or RFU - these are not distribution lists

Registration - Clubs should by now have removed any non-returning AG players and parents if appropriate. As we are past the 45-day point - by a long way - if these are training or playing it is a breach of Reg 15. Senior players still showing renewal required should be completely deregistered and removed (if not holding other roles in club of course) and don't forget that (at the council meeting date) the transfer deadline has passed

Festivals – Joe Walsh

Bournemouth RFC: After a change in BRFC's governance structure just over 6 months has elapsed and an update to RFU Governance Cttee has become due on progress against the new administration's plans. Council members will have seen the response provided in mid-January via Nicola. As the situation is fluid and RFU Governance also requires our help in tracking progress, a request is made to furnish any evidence relating to BRFC's current standing via our Hon Secretary please.

Salisbury grant and loan application: as part of D&Ws agreed work to support club projects that match our criteria we assess grant requests from time to time. In the autumn we gave 'in principle' support for a project to install solar panels on SRFC's clubhouse roof and this has come to fruition, with a grant of £2.5k and loan of £7.5k repayable over three years finalised in January 2025.

Devizes RFC: have requested a £500.00 Club Support Grant for the setting up of a new Girls section, the funding is to be used as part payment towards new Playing Shirts.

This has been agreed by the Club Support committee.

The suggested Area Representative grants in the draft budget, are still work in progress regarding how they will be managed. They will have a maximum value per application and the Club Support Committee will have the final say in any award.
