- WD rep is setting up Club visits to all 8 clubs during next season, other reps should be encouraged to do same – SW will be trying to do this as well – note: these should be on a mix of Senior Mens/Senior Womens/AGR playing days not just Saturday afternoons.
- To ensure Rep Rugby continuity specifically between U18 / U20 / Seniors (M&F), the Exec/Council should ensure contact is maintained with players as they progress through AGR and with their senior clubs, especially if Prem Academies are involved

Notes

Brief summary of progress or problems. Feeling around the clubs. Comments on agenda items

1)- All clubs pleased season completed 1st season back post covid. Some had slowly starts but things picked up as the season went on, others maybe struggled at times but all clubs got through and completed the season. Age grade numbers also looking good, especially Girls at Oaks. Clubs have roles that will need filling ready for next season.

Oakmeadians- thanks to fund-raising within club it plans to do a lot of pitch work during the summer, funded by the club.

- 2)- Reminder to clubs to continue with data cleanse where possible especially around updating key officers when roles change. Concern raised about the problem of getting e-mails for the older generation but they are key aspects of clubs who often help with financial support- don't want to have to remove them from club records. Also, can wording about verification of e-mail be a bit 'stronger' to try to encourage people to undertake this simple task.
- 3)- Tours- reminder requests need to be submitted in plenty of time, not at the 11th hour. GB mentioned he has had to provide the RFU with a note on the outcome of all tour matches. The

group was concerned this was needed since, often, tours are more about the experience rather than the result.

ACTION- JC to investigate further the need for this

- 4)- Courses have been brought forward in the calendar and details have been communicated via the Community Game update.
- 5)- JC advised the leagues had been issued today but some are either incorrect or not showing. JC reminded the meeting the main point of contact around any issues for league games is the league secretary, they can also help when any issues around struggling to play a game. There was a request that teams show a bit more respect to each other, avoid leaving cancelling to the last minute, if not staying for food let the host club know etc. Also, discussion around Gameon, which can be used at L9 to get rugby played but it was noted some teams, especially 1 team clubs are often reluctant to adopt this and/or lend players to get a game played. LC agreed to feed this back.

ACTION- LC to feedback concerns around Game-on.

6)- NE advised the Age grade playing Calendar has gone out to the Age groups via WhatsApp. More details and entry forms to be sent out later this week via WhatsApp and GMS. Hope to have fixtures issued by end of June. Also, to note applications for the National Youth council are now open.

AOB-

NE asked how it is best to consult with clubs around Age Grade issues. In the past its been via 2 Age grade forums (Dorset & Wilts) Should Age grade discussions be linked to the cluster? Thoughts were more maybe best via Forums but to also include where needed in the clusters

JC mentioned that at a webinar last week on Age grade affiliation it was mentioned that the window for affiliation/reaffiliation will be open from 1st July, however, the players will not formally be changed in age band on GMs till 1st August. Some concern was expressed by one club that this would impact on their membership process, which they have set for Age grade from 1st August. JC advised that the process is a national one, not one for individual clubs but would contact Mark Saltmarsh to request that if any bulk e-mail is being set to parents can clubs get early warnings.

ACTION- JC to contact Mark Saltmarsh.

LC thank everyone for all their efforts during the last season and wished everyone a restful summer.

No attendees from - Cricklade, Minety, RWB, Swindon, Supermarine.

With only three clubs in attendance, it was asked by the Chair if there were any issues that clubs wanted to raise.

Chippenham – The only issue was senior rugby and getting out as many teams as possible next season, with the new league structure in place. Overall playing numbers in the clubs mini, junior, girls and women's sections were strong with the exception of the senior men.

There had been some loss of senior men's players when covid restriction ended and the club were now focusing on bringing younger players through from the academy into the senior game after a two-year gap and as such would unfortunately be dropping out of the D&W Colts league and concentrate on bringing them inti the seniors playing once a weekend.

Chippenham have started a new women's section during the season which will entering into the women's leagues at the start of next season.

Sponsorship had been the best it has been this season, with one of the members focusing on it even through the covid period.

There was nothing else difficult coming out of the season.

Swindon College OB (SCOB) – Again recruitment of players into the men's game was the club's number one concern, with no mini/junior section to feed into the men's senior section, this was followed by sponsorship.

The club had produced a sponsorship leaflet outlining packages available.

The club had a good relationship with the Kings Arms pub which they have been using for the past 8 years.

Sutton Benger – The club had done well with the recruitment of players over the last couple of years but were worried that there might be some that may drift away this coming season and being a one team club might be struggling for numbers, which had been reflected this season with low to no replacement players on the bench on some match days. Also, again with no mini/junior section there was no pathway through to the senior men's team, they were reliant on players friends and friends of friends to field a team.

One of the main concerns for the club was that the local pub which had been their base has changed hands and costs were going up. With the league restructuring and less games being played the club were looking if they could utilize the local village hall as a after match venue.

JC said that it had been recognised by the RFU Council that playing numbers were an issue and looking at what could be done to help get the numbers up. It was hoped to get some feedback by the 17^{th of} June. JC also said that 'game on' was still in place for the lower league and encouraged clubs/teams to contact their respective league secretaries with any issues so that we could get rugby played and not loose players resulting from games being cancelled.

League Restructuring:

JC reported that the league structure had been released the day before (23rd May) and that officially the date for the release of the fixture's was the 15th of June, but at the SWDOC meeting it was hoped that they might be available at the end of May or first week of June.

JC went on to explain that there were some weekends which were down as 'Red Break Weekends' which would not be used by the leagues to play any postponed games in but could be used by clubs to play fixtures in if mutually agreed with another club. The weekends that were down as reserve dates in the structured season would be used to play rearranged games in.

It was intended that the leagues would be finished by mid-March and then the RFU Cups Competition would be played. The RFU Cup competition would only be open to club's 1st Teams and entry would not be until January '23 when the league season would be 2/3rds of the way through.

For those teams not wishing to enter into the RFU Cups, D&W would be offering a Cup competition to run at the same time based on teams in the same playing level, which would also include club's lower teams. Again, entry into these Cup competitions would be in January '23.

Courses - Webinars:

The details of the Electronic Match Card (EMC) Webinar had been circulated. JC said that he was not aware of many changes to the Electronic Match Card and had along with Sean Macey put together a ready reckoner of what to do. It is the responsibility of the home club to send in the result. In areas where they may be no Wi-Fi signal results could still be phoned in.

DW said that some of the webinars would be repeated during the closed season, EMC, Age Grade Affiliation being two.

DW pointed out that the DBS online introduction should be done prior to doing or renewing a DBS, also intro to Safeguarding done prior to DBS. Intro to Safeguarding should be done every three years

Other courses it was recommended to do were 'Tackle Safe' and 'Headcase Concussion' (redone every 3/5 years) recommended for both coaches and players.

Coaching courses will be run in earlier batches no dates at present.

Future Meetings:

SM suggested that it would be good to have some face-to-face meetings at a club's venue and suggested that possibly three during the season, one at the start, mid-season and at the end.

Suggested dates of a first meeting early September would be circulated in August and a venue, which is central to all clubs.

AOB:

GB pointed out that there had been an amendment to RFU Regulation 10.7 (Touring) that a written report would be required from touring teams, with where tour was and results etc. Clubs advised to check the relevant regulation and include in any club touring policies.

Reminder:

To all clubs, following club AGMs to ensure that GMS is updated with the club's officers.

MM suggested it was time to reassess the D&W Target Delivery Plan, which currently is

- 1. Player Recruitment and Retention.
- 2. Woman's and Girls rugby.
- 3. Club Support.
- 4. Under 17's Under 18's Male Retention, Recruitment and Transition (RRaT)

MM asked all Area Representatives to discuss this with their clubs and report back.

SM expressed concern about Sutton Benger RFC, relating to the possible loss of use of the pub for after match events. SM to contact them for an update.

ET reported that Swanage & Wareham RFC are developing a Players Charter, he also referred to Oakmeadians RFC Ladies may also have the same type of document available. ET has requested that Swanage & Wareham RFC shares this document with the rest of the West Dorset huddle.

AM reported on the West Wiltshire huddle which was last held in February 2022. The last meeting did not take place all though the clubs had expressed a wish to hold a face-to-face meeting instead of on Zoom.

The reason for the cancellation was no club submitted any Agenda items.

AM did report that JC held a Zoom call with any of the clubs that wished to participate.

AM requested that the team "without lead" should be removed.

The West Wiltshire huddles will resume at the start of next season and will be face-to-face.

CB asked do the Huddle Leads need extra support from Council members, relating to the non-engagement of some clubs.

MM suggested that we need to investigate the reasons why these clubs are not engaging with the D&W.

CB suggested that if clubs are unwilling to engage with the D&W, then the D&W should remove the offer of support to that club.

6. Non-Area Representatives Updates: Age Grade

NE

Age Grade Playing Calendar

The Age Grade Calendar for the male age groups has been completed. Activity by the Bath Rugby Community Department has been included for the first time and the Bath Rugby Academy Activity (including DPP) has been shown in more detail. This should address a few issues that occurred this season and contributed to the cancellation of some club games.

Representative Rugby and DPP

The CB is associated with the Playing Opportunity for the DPP but in practice this is delivered by Bath Rugby. The involvement of Lee Murgatroyd as a manager for the festivals within the Bath Rugby DPP has improved and will continue to improve liaison and Matt Lishman who is the Bath Rugby lead for the DPP is very supportive. There is a particular focus on improving the communication when players complete the DPP process without being asked to join the PDG. There will be more communication with individual clubs and schools as well as the CB.

For next season there are some changes to the DPP with the Under 14s starting later. There will also be Club Festivals (run by Bath Rugby) which are in the AGPC and will form part of the selection process for the DPP in addition to the current trials giving the boys more opportunity to be seen in game situations within their normal playing environment.

The Under 17s and Under 18s come under the Adult Representative Rugby but we would like nevertheless to add our congratulations to those who have run the recently completed Under 17's programme.

Age Grade Competitions

We have been able to run the full suite of Age Grade Competitions with similar entry levels than prepandemic. Quite a few teams have been working close to the edge of viable numbers particularly in the older age grades (under 16's and under 18's) and it some have found availability to be less consistent meaning that a larger squad may be needed to get full sides out regularly. A small number of teams had to merge or withdraw. That said, the vast majority of games were played, and all the planned competitions were completed other than the Under 16 Championship Plate where the teams in Phase 2 of the waterfall were restructured into three rather than four groups.

The vast majority of games were played in a good spirit, and it was great to see Clubs sharing positive comments about each other and thanks on the WhatsApp groups. There were still a few games where the behaviour of players, coaches or parents fell below what we expect, and it must remain a priority to keep on top of this. We are re-emphasising to Clubs the importance of pitch-side protocols including the erection of suitable barriers to keep spectators well back, the identification of technical areas for coaches and replacements, and the necessity of keeping unauthorised people off the pitch.

The Competitions Team will be reviewing the rules over the next fortnight and presenting some proposed revisions which we will circulate to Council ahead of the next meeting. We want to maintain the flexibility and informality which we feel is an important part of Age Grade Competitions but need to tighten up a bit on the reasons that are acceptable for postponements, the criteria for selection when Clubs enter more than one team, and the scoring systems in relation to walk-overs and in respect of try bonuses.

The entry forms for 2022/23 will be going out this week which is a little later than hoped so draft fixtures will be available in early July.

Schools Links

During the next couple of months, we will carry out a survey of the links between our Clubs and Schools. It has been a while since we have done this, and it needs to be re-energised.

Youth Forums

The Youth Forums have been dormant of late, and we will be encouraging them to meet. Dorset needs a new Forum Chair. In due course it may be worth reviewing whether the Youth Forums might be better linked with Huddle areas than the two counties which are not used in any other D&W contexts.

MM asked about aligning the Age Grade Forums to the Area Huddles, it was agreed to review the structure of the current arrangement.

Woman's & Girls BB

See the report dated 19th of April 2022.

CB reported on the high standard of Core Values within the Women's & Girls Representative Rugby programme this year.

CB reported on a meeting with Bath RFC regarding the Super Clusters, next season these will be ran by Bath RFC in conjunction with the D&W.

For the 2022-23 season the RFU will be instructing CBs to run a Under 16's Girls DDP programme, the Girls DDP will not be linked to Bath RFC.

CB reported that Bath RFC have held Under 16's Girls Performance Hubs within D&W, without informing the D&W. Twickenham will be informing Bath RFC that is not permitted and should stop. Bath RFC priority should be towards Under 18's Girls only, which might result in some form of Under 18's Girls DPP.

CB also expressed his concerns about the number of clubs becoming affiliated to Bath RFC, with the promise of coaching support etc. He is concerned that the expectations of the clubs will be raised to an unacceptable level. If the Area Representatives hear that the clubs are not receiving the level of support promised by Bath RFC, please report to the Executive Committee who will go back to Bath RFC and highlight the issues.

CB reported that there are several issues regarding the Women's League structure around travel, which may result in match cancellations which may open the need for locally based competitions.

GB outlined the proposed D&W Under 18's Girls 1000, this was agreed that the Area Representative should move this programme forward.



Current Budget update:	Have not been advised of any budget available. g) Adult Male Rugby – email text from NMcM

Hi all.

As most of us are aware we saw a reduction in the amount of adult male rugby played in season 21/22 compared to that immediately prior to the pandemic. We don't yet know the degree to which the pandemic has caused this, or to what degree Covid has simply accelerated the decline that we were beginning to see prior to it. Thanks to all of you for your hard work on alleviating this over the last year – without doubt it would have been in an even worse place without all of your input to it.

Over the next six months or so we will be working to create a new blueprint for the whole community game, building on the working groups currently underway around the contact game, non-contact game and Club of the Future. This will consider all aspects of the game, contact and non-contact, men and women, boys and girls.

However, in the short term it is important that we take a hard look at anything we might be able to do ahead of next season to stabilise/reverse the decline in adult male rugby. In reality we have c.4-6 weeks to consider this and to implement any change/introduce any interventions ahead of players and clubs returning to training/matches. To assist in this, we are seconding a small number of people from across the organisation (including Rugby Development, Marketing, and Insights staff) who will be working solely on this for next few weeks to a tight and focused programme. More information will follow however a large part of their work will be engaging directly with clubs and CBs, so should they reach out to you, please do give them all the support/input you can.

The scope of this project is very specific – areas of adult male contact rugby where we can deliver impact in the amount of rugby played in season 22/23 with a specific focus on the first half of the season (i.e., Pre-Christmas). Lots of longer term (and broader) ideas will inevitably come up and these will all be logged for utilisation in the longer-term project however for now it's critical that we stay focused on the area of major concern right now.

Thanks, in anticipation of your help and look forward to catching up on this soon – if you have any queries on this please don't hesitate to let me know.

4th game @Dings Crusaders RFC a stunning club and pitch. We lost 29 - 26 in a great game, where we were 14-0 up at half time. 2nd half they came back at us and pulled it back and took the lead. We then stepped back up and pulled it back, but they just edged the win. A great game. The boys really stepped up to another level again and in patches looked unstoppable.
