Book the Volunteers Event evening – 12th June 2025

VP/County Membership – GB asked what the plan regarding membership payments due on the 1st of October 2025 was going to be. AH reported that she is expecting an influx of payments on that date, due to the non-cancellation of Standing Orders by VP members because they think AH should cancel the Standing Orders on their behalf and the failure to set up new Direct Debit.

Area Representatives

As can be expected at this point in the season no meeting in this period. Meeting booked for 15 Sep (S Wilts) and proposed date in early Oct for E Dorset so far

No meeting related items that have been put to Reps for sharing:

Alan Ottoway forwarded to El (E Dors) that some community support for the Bournemouth area may be available from Morebus.

The Grants situation has been discussed among the 5 of us. Ed (W Dors) offered to pull a form together for clubs to use, including the requirements for clubs to have grants (Dev Plan and Accounts submitted) plus of course not paying players (Reg 6 refers) I hope we can get this form adopted ASAP. A club has request support for purchase of VEO. This has been discussed with Facilities which has resulted in the following from Alan "I'm seeing lots of other cost factors impacting clubs and am worried about undue focus on 'performance' at clubs rather than memberships, mini & junior sections activities (which tends to be used to prop up the economic activity of most of the clubs that have strong age grade sections whilst having a generally weaker strength of vote at Board level), and basic infrastructure investment". We are not sure but feel there has been a push for lower-level clubs to use them. We don't really know where this is coming from. Maybe our RFU Club developers can join in this conversation at some point.

Player Registration numbers for clubs have required pushes through Reps as some have been low – see Governance report also.

I have issued a generic agenda heading and some notes to all reps, but of course local interests must come to the fore.

Apologies for a short report, but although it looks like little has happened, I can assure Council that all of us are in continuing to contact and discus with clubs any points that arise.

DW asked if we could find out which clubs have a VEO.

West Dorset

Concern over protocols followed in Wimborne Match cancellation given recent rainfall 2. I have received 2 requests for local grant funding which I will follow up if you believe these meet criteria

- 1. Sherborne would like funding for an initiative visiting primary schools in the area to coach tag rugby
- 2. Dorchester would like shirts for newly formed U14 girls' team

Governance

Discipline – Three cases reported (08-09-2025)

New Panel members wanted – 12 new volunteers

Recognition of sanctions from RFU Member Clubs

19.2.26 Misconduct – Not a Red Card incident

Starting this season the Discipline Panel will asks the club to hear this type of case first and submit a report to the D&W (New 19.2.26 paperwork to be issued to clubs).

Once the club report has been submitted to the Discipline Panel, the panel will review the club's findings. Which may or not be excepted, if the panel disagree with the club's report the case will be heard in the normal way.

More details to follow.

Data

There is a growing need for clubs to consider the people of their club lists to ensure data is correct and complete and that emails have been verified. There is a Data GMS session available for clubs to participate in if they request it. https://app.smartsheet.com/b/form/5a4b00c09a864841853d1bfcb137cb1f

For next Council I should be in a position to be able to identify the clubs really needing help The CB GMS is, unfortunately, in a bit of a mess. Weve been through a situation where every time a new registration is made to a D&W club, the player (and Parent where applicable) was added to the CB. This has resulted in me having to remove these people from the CB GMS. FSI have now fixed the issue they tell me so I will start working with Hon Sec and Membership Sec on pushing our data accuracy to where it should be - Most VPs have less than optimal data!

Registrations

Age Grade – really only starts this weekend so no comments at this stage on numbers or progress. A reminder that new players have 45 days to be registered to play, but must be registered before playing any games, including reregistration's

Adult – been slow for some clubs, a reminder again that all clubs as some have been slow. I will continue to share the figures through Area Reps for action where needed. As we run through the opening weeks of the season club registrars will be reminded of essential action

Safeguarding

This year's activity

- 1. Approving 17-year-olds to play adult rugby- We received multiple requests for 17 yr olds to play adult rugby even before the start of the adult season, several of the coaches were extremely disgruntled at being told that until the safeguarding self-audit was complete, I could not finish the approval process. Several sent emails to other council members in a bid to push the applications through. I have spoken to other regions who have refused to approve 17 yr olds to play adult rugby until at least October. If they were approved to play at the tail end of last year then I am happy that I am within guidelines to approve, however I would like to seek assurance from council that it is ok for me to approve the current 17 yr olds to play adult rugby despite the season only starting on Sunday. I have also rejected several where the assessment was not completed for each player but had been copied and pasted from one application, I will continue to monitor this and will reject any for whom the assessment is copied. I have provided each club with an assessment tool to be used alongside any assessment that they carry out in house.
- 2. Multiple playing up and combining of age group requests are also being submitted. We are assessing the need for these as they come in as the criteria is quite strict. Considering that the season only started on Sunday I am concerned that clubs are not looking at alternative options before putting in requests. For example We have had a request for a 7yr old girl to play in U9 as she is too large to play in U8 and is being played up at school, this is not something that should be happening, so we are having to look into different options to maintain regulations and also ensure that we are allowing children appropriate access to rugby opportunities.
- 3. Play it safe course bookings are coming in with 3 courses already fully booked. Clubs have been asked to look to get bookings into the diary asap to ensure that the courses are not cancelled by the RFU team. Courses are allowed to have 20 attendees, and no walk ins are permitted at all. Some clubs are reporting that the booking process is too clunky, and coaches are having issues booking on, there is nothing I can do to make the process smoother other than ask the CSO to sit with the coach and book them onto the course.
- 4. The Introduction to safeguarding course is now due to be completed by all volunteers on an annual basis and before any DBS can be processed, this is because the information has been removed from the Play it safe course and is added into the introduction to allow a deeper level of discussion to take place on the course.

- 5. The following clubs have not yet completed the Safeguarding self-audit, this must be completed in order to approve any festivals, tours or playing up or down approvals so please can the following be reminded to complete (Names are as per list from the RFU Team last week) Amesbury, Chippenham, Colerne, Cricklade, Dorchester, East Dorset Dockers, Lytchett, Marlborough, Melksham(Completed on Friday) Minety, Pewsey Vale, Swindon College Old boys and Warminster.
- 6. When checking GMS there are multiple clubs who have coaches listed without current DBS checks in place, clubs are to be reminded that all coaches need to have full DBS checks in place. Coaches who have applied but not yet cleared are able to coach with supervision. And to clear their GMS.
- 7. Safeguarding deep audits are being planned around the results of the self-audit as well as following any concerns from last season. These will be spread across the region and across the season.
- 8. The Dorset sports welfare officer has forwarded details of some courses that are available for volunteers, these have been shared with the clubs.
- 9. submitted in advance of the player turning 17 so were held until after the relevant date. Reminders given for full playing assessments to be completed, especially where clubs do not have colts teams and so colts coaches are unable to assess.
- 10. Festival and tour applications continuing to come in. We have had several where the hosting club has not gained permission for incoming clubs to attend the festival or tour, these have been picked up when the WRC ask about them. Clubs are constantly reminded of the need to ensure these are fully completed. We have had several that have gone to Gerald, but the clubs have not been notified of approval which has meant we have needed to chase. This is difficult if there is no communication coming through to confirm if this has been processed or submitted with errors. I would like to work towards a more streamlined process for next year where the safeguarding team can be sure that any incoming or outgoing permissions are being worked on as it is causing extreme stress for club organisers as well as additional work for myself and Joe.
- 11. I have been notified that people have been appointed to the representative team but no volunteer form, DBS check or play it safe check has been completed. Can I please have assurance that someone is looking at these and that we are not just appointing friend to fill posts? We need to be consistent across the CB when appointing to roles, a volunteer form must be completed for every single person (We missed this on one person, and he was totally unsuitable and had been under investigation by the police but we appointed him Girls coach!) We cannot leave ourselves open to this type of risk. I was not copied into the notification of the coaching/ Management team but was forwarded the email after appointment! As the Safeguarding Manager all appointments involving U18 staff should be notified to me so I can check the GMS is correct and there are no outstanding issues. I've also been advised that one of the games has been scheduled for the end of my bank holiday which will automatically exclude some lads as holidays will have already been booked, these need to be planned further in advance and avoid the school holidays surely?
- 12. Multiple clubs have reported an increase in poor behaviour on the touchlines, reminders have been sent out about the code of conduct and the need to ensure parents agree to comply with them. Bystander training was delivered locally last week for several clubs.
- 13. The CSO Spond group continues to be used to share relevant safeguarding information including a great photo to explain emoji's being used by children that can be shared with parents, a Ted talk about talking to kids following games and many other resources that are being shared online.
- 14. 5x Play it safe courses have been held across the region, with a new tutor in place based near Trowbridge this has meant that I have been able to plan the courses with someone else delivering which has freed up time. Another 6 courses are scheduled for coming weeks. Getting people booked onto the course

	continues to be challenging, mainly because people find GMS unwieldy and are struggling, we continue to ask if we can look at an alternate way to get people booked on but no movement yet. Ideally the CSO should be able to trigger a booking with the person able to confirm and pay. We have been told to turn away anyone who attends without a booking.
Current Budget update:	No idea as have not been advised of the budget for Safeguarding
Proposed Activity (including estimated cost)	 Continued attendance as needed at clubs for whom issues have been raised. Audits to be scheduled for several clubs where incidents have not been managed well. Plans for a CSO update event are required. I am speaking with the CSO to try to find an appropriate date/ time as we will not manage to get everyone required

> Club Support

Clubs at Risk

This is a standing item on Club Support agenda. Sometimes the club itself, or more usually the 'grapevine' leads us into a supporting role should the club in question call upon our services. Usually the club knows where the issues lie and only their own efforts can address a problem, although recommendations on methods to continue playing without full squads within our league structure can be especially useful. At present we are keeping an eye on a number of clubs. This is simply because the definition of 'club at risk is any club that could struggle to operate within the next 2 to 3 years. That of course could be a much larger number of clubs 'at risk' that anyone may initially imagine. Losing one key sponsor (Bmth) or a respected team coach (Weymouth) has happened in the past 18 months. However there are many other ways our clubs can find themselves under pressure from e.g. a migration of players to a local competitor or loss of service personnel whose units are pulled, to a major facility issue that compromises their ability to play at their club, or the potential loss of a facility that is owned by a third party. Please report any concerns via the Secretary or to me and we can offer help.

AH updated the meeting regarding the status at Weymouth & Portland. W&P colts are looking to cluster with other clubs.

Facilities & Equipment

Calne RFC have to replace posts which we will support should that be necessary.

Grants

The agreed D&W budget includes resources to help our clubs based on need, which includes means testing. Two clubs are presently unable to be supported, having breached RFU regulations that automatically bar them from our (and RFU) financial help.

Volunteers

As you'll be aware there will be some changes to the volunteer recognition program this season, with Honda's partnership coming to an end. We are in discussions with a potential partner to support the program and will update on this shortly.

As the funding e-mail outlined, funding to support volunteer recognition will be included as part of the overarching CB payment, rather than a separate programme payment, this season. This consolidates funding, gives CB's greater flexibility to tailor recognition activity and improves effectiveness, with the funding confirmed at the start of the season. The funding can be used to support volunteer recognition as you see fit, including local volunteer events to support the Volunteer of the Year awards

Nominations for the Volunteer of the Year Awards will continue to be coordinated centrally, with nominations opening in January/February, and as previously nominations will be shared with you to review, shortlist, and recognise as you choose, at a local level, with a national event taking place in September. Girls

County U18

Currently working on fixtures with Bucks, Berks and Oxon. We will be hosting Berks this year. Trials will be Sunday 2nd November.

Due to the number of U18 clubs playing outside of our CB in leagues we are unable to create leagues this season. However, I intend to speak to clubs in December to start the process for the following season. It has been suggested that an U18 festival be created/waterfall this season.

There are a number of clubs with different age groups with some clustering. They have been asked to ensure they fill in the relevant paperwork.

Many of the clubs are celebrating the World Cup and using it as a spring board to recruitment.

The PDG FP U16 girls have assessment on 1st & 8th September at both centres. We have had some issues with a club deciding to nominate two days before. After discussion with Gordon Harding, we have allowed it as a one off as the girl had already been told by the coach. I will be addressing this with the club concerned and possibly making them a priority for a club visit.

I am hoping to start the Hub meetings by the 3rd week in September for Women & Girls to try to encourage more clubs to engage.

We are getting coverage via the BBC with Wiltshire Radio getting in contact and Solent doing a voice piece for introducing songs on their Breakfast show this week. The Sherborne RFC Women have been busy with their script today.

The Facebook page will be live by the end of the week.

→ GB have received an email about Merit League Funding Applications for 2025 – 2026 Could this funding be used for a Women's Rugby – D&W Merit League, like the men's version from a few years ago. To be reviewed over the coming year at the Competition Group Meetings.

> RFU Council Representative

After a long hot & dry summer we have finally got some rugby under way with the start of the league season last weekend.

As a result of the weather have been sharing info with clubs on how to assess hard pitches and guidance has also come from the RFU & the SW via the league secretaries. This resulted in all but 1 game being played last Saturday with 1 game being moved to the end of the month when the club followed the correct procedure as shared with clubs when they felt the team was not ready to play.

Hopefully the weather forecast gives us more rain this week and we are now over the worse of the hot summer weather impacts on our game.

Clubs are reminded constantly of the need to keep their GMS data up to date, especially key officers (golden roles) since this is what the RFU and CB use to send various communications to in the clubs. I have reminded clubs on this.

From the league secretaries' point of view our main point of contact with teams is the nominated league contact and we managed to get all the teams to confirm/update/change their NLC without any sanctions being incurred

Linked to this and with thanks to President Sean and our GMS guru Dave Wookey, we did hold a session with clubs in mid-august, aimed at trying to arm clubs with information to try to reduce fines etc. Whilst the attendance numbers was a little disappointing, it was felt by all involved the session was worthwhile. The slide deck and covering notes has subsequently been shared with the NLC's for the D&W teams and also Chairs, Secretaries and Adult Male contacts in clubs, with a request the information is passed on in the club. The Women's game is slightly different in that is overseen, currently, by the RFU Competitions team, although that might get split out to the ROCs in due course. (Watch this space).

The RFU National Cup draw that is for all 1st XV's playing at Counties 1 and below has been issued. All eligible teams were entered unless they had opted out. Subsequent to the draw being issued a couple of teams have said they didn't want to enter, so their games are now shown as walkovers. The 1st round is played on Sept 20th, with the next round late October. So far across the Country the feedback has been positive that the cup is now, partly at least, in season.
