Agenda

1 GMS status – cleanse of non-members etc, ensure data is updated – especially players

Clubs must ensure that data is cleansed from non returners during first half of the season – we say by Christmas. Be careful NOT to remove relationships when removing from club!!

With the prospective of adult player re-registration/self registration its important that players can access their records.

If you find duplicates or issues let me know and I can easily show you how to clear the issue or if cant be done locally how to get the RFU to clear them.

Comment that GMS is unworkable for registrations requiring V12 and full GMS to be used for registration, well V12 will go out of use once the self registration comes in. just like it has for Age Grade, so all club registrars will have to do is approve and then assign to team. RFU rep reported that this is awaiting some work by FSI (the GMS developers) before it can be brought in for next season. He and some clubs worry that players wont comply as all they want to do is play rugby, a considerable debate followed on whether registration should be required below L7, however all agreed that there was concern about nomadic players.

[Additional Comment from Mike Banfield: I'm for adult player registrations being online even though I know it will be difficult with some who try to do on phones or don't have lap tops. I get that maybe at level 10 there may be a need for the previous NER type players.

Paper forms and paper match cards have to be a thing of the past !]

Seems like only parent gets it which seems wrong to me and should be all on the online form.] - This does need sorting, the smartsheet system is derived at RFU so D&W approvers have no control over who receives the response.

DIVERSITY & INCLUSION.

We have successfully found a volunteer for the diversity and inclusion lead. Ben Shuker from Chippenham rfc has had all the volunteer paperwork approved and I have interviewed him by phone. He will need an email address and to be added to the Dorset & Wilts website. Ben has requested any information from D&W and RFU and would be willing to undertake training but would need help with any cost attached to that.

SAFEGUARDING.

I have been in contact with a perspective volunteer who has completed the volunteer forms but now does not want to take part in an interview. I have sent out forms to another candidate and am waiting for them to get back to me.

- attendees needed, 5 days before course date or the RFU cancel them. 6 week lead time for new bookings: This is highly frustrating and I fail to see the need for 6 weeks. It takes less than 15 mins to add a new course to the diary and I have asked Tim on multiple occasions to book a course at 5 weeks notice but have been refused.
- j) Clubs are able to contact a tutor using the tutor map, but cannot book a course. JF books the course as soon as dates identified and details sent by club.
- 2) New Safeguarding tutor being trained based at Marlborough, may be able to deliver after Christmas but sadly the process appears to be exceedingly slow from expression of interest to being able to be deployed.
- 3) CSO calls have been pre-planned but JF is unable to access the Zoom call without Gerald. Sadly Gerald did not attend the first one which was planned and no communication with Gerald or Chris was possible. This was a vital first call for all newly recruited CSO/CSA. JF is calling each of them individually to chat about any issues arising from the first few weeks of the season. JF will hold a meeting for all new CSO next week on Teams. If this continues to be an issue then JF will look at alternatives as many CSO had given up valuable time to attend as well as CBSM time.
- 4) JF Waiting on information to be able to deliver the **Bystander training**, Chased Scott Sturdy again, he is OOO until 2nd Oct.
- 5) Emailed Gerald to ask him to book a venue for the **CSO training/ Conference** -No Response. Can this be looked at please? Venue previously suggested was Pewsey Vale?
- 6) Approvals for 17-year-olds. Using the RFU Smartsheet approval online, it has been advised this week that the RFU portal one is only updated once every 2/3 weeks. Luckily, I have been keeping a live document of my own for all D&W Approvals, club approvals, festival approvals, age grade combining, playing up and down. I am clearing the 17yr ones after checking details and often discussions with the coaches whilst Joe Walsh is still able to approve all of the other approvals as he is able to access online. He is unable to assist with face-to-face audits as he is out of the country.
- 7) No applications to note for Assistant CBSM. One enquiry but he didn't follow up. Need to recruit someone to help with audits as not sustainable for JF to do them all on her own. Needs to be someone with comprehensive safeguarding knowledge that will investigate the detail at clubs rather than the surface.
- 8) D&W website has many out-of-date links and a strange thing on the safeguarding page. Can we please have it updated with this year's info and can the button be a different colour to all the other buttons. Clubs are being asked to prioritise Safeguarding on their front pages and as a CB we should be no different. Where is the Policy that was put forward last year and the volunteer recruitment policy? This should be easily accessible on the page along with the Volunteer application form, festival form and the links for the playing 17 yr old as adults forms. I will provide the updated information. Is there any way that I can be given access to update my own pages? I currently update the Dorset Healthcare ones at work

RUGBY SAFE.

I have contacted every club in the CB to introduce myself and confirm that they have an RSL in place.

I have contacted 40 clubs - thus far 8 have either not responded or do not have a named RSL in place. However, going through GMS it appears that not all of the remaining 32 cubs has updated GMS with the name of the RSL so it is tricky to be certain at this time.

I have been to see the RSL at Pewsey and to give him some advice on getting up to speed with requirements.

I have had countless phone calls and WhatsApp exchanges with many clubs fielding questions and offering advice - some of it not necessarily what the clubs wanted to hear but in reality what they needed to hear!

I am still not entriely convinced that I have a complete list of all the clubs of which I am meant to have oversight.

Dave W has been really helpful and showed me how to access reports via a Teams call, but i havent managed to replicate what he showed me! He did suggest that i look on the CB website as this will have a complete list of all the clubs within the CB, which I have done, but this differs ever so slightly to the lists that I have been given previously.

(Currently updating the club contact section of the website)

WEBSITE.

The website is missing crucial information. Safeguarding should have its own button and all the information should be easy to find. There is no mention of county lines, 1 of the biggest problems in the 12 to 18 age group. No information on mental wellbeing. Most deaths in the under 35s is suicide. There is information in areas that is not easily found and some in the wrong place. Is there a chance that I could get onto website to change the sections I am supposed to be dealing with.

Safeguarding has had a direct link on the home page to their page for a couple of years now. There are currently 22 buttons on the home page of the website with direct links to their own pages.

Regarding the website content, we have continuously requested all sections to update their pages, for example it is recorded in the Council minutes for the 19th of September 2022 that I asked Safeguarding to update their page. This request has been repeated at nearly every Council meeting since

Without the correct content being supplied by each section, we cannot update the website.

Submission for CB Council meeting Sept 2023

These points were to be raised at the meeting on 26 September which was cancelled/postponed.

The suggested date on 10 October coincides with a holiday I have booked so will be unable to attend. I therefore submit these for discussion at Council. I don't like missing meetings and this will be the second I have missed this season, which is a very bad show on my behalf, but in this case (as was the last) family first.

1 System parity between Mens and Womens transfer procedures

Sean and John Constable are aware of this issue already.

I quote a comment made by a colleague in another CB following a concern we both had following an attempt to get a transfer through – I had to ask Bob for the contact at the other club for mine by the way as I had no way of obtaining it.

"Having been an Adult Registrar on GMS for many years, I am very familiar with the male player registration system on V12. Recently, I was asked to train a new volunteer as a Female Adult Registrar, which I did and she went ahead to try to register 2 new players who had been previously registered at another club.

In the adult mens administration, this is an easy task for volunteers to just click "yes please" to the GMS prompt in V12 which asks "Do you want to initiate a player transfer?". You click yes please, the Transfer Request Form is generated automatically by the system and is sent to the relevant Adult Registrar at the other club informing them of the players' intent to change clubs. And the reregistration follows automatically over the next 7 days, with GMS re-assigning the player to the new club's GMS system and letting the new Registrar know the date of effective registration. This is a simple and efficient system which I assumed was the same for all players.

It appears not to be so.

Female players, I am reliably told by GMS Trainer Dave Wookey cannot be transferred in this way. When I tried to transfer the player, I received a message to contact Bob Morrision, at the RFU Women's Results & Registrations Office, which I did. He explained that I needed to:

- 1. Fill in a paper copy of the RFU Registration Form for the Player and obtain a wet signature
- 2. Email if to him so that he could initiate the transfer
- 3. Fill in a paper copy of the Player Transfer Form and send to the Registrar of the previous club to gain consent from them to transfer
- 4. Wait the required 7 days AFTER receipt of paperwork to receive confirmation of player registration.

Despite this seeming ridiculously lengthy and not possible for new volunteers to manage well (ie they have no idea who to send the transfer forms to at "previous clubs"?), we followed these instructions and sent the paperwork to Bob. It transpires the paperwork did not arrive until the Monday (the player was due to play that Sunday, we had explained this to Bob) and so we were sent an Expediation charge of £45 (needed in order to "speed things up" and achieve the registration transfer by the Sunday. We (reluctantly) accepted this and were then further told that the link for the payment could not be sent to us until the previous club had confirmed their consent to release the player - which of course, previous clubs are not motivated to send through in a timely manner so there is very little chance of that happening.

The upshot of all this is a huge amount of extra volunteer time and effort being needed to transfer a female player over the extremely simple and efficient way for a male player - on the SAME system (GMS v12) with the SAME software to deal with this - and the impact is that these two ladies will NOT be able to play in their game this Sunday, whereas, for any male adult player, they would have be facilitated to play.

This seems to me to be a clear discriminatory issue - surely, if we are serious about Volunteer Retention, Growing the Female Game, and Player Participation there should be NO DIFFERENCE at all in the registration process for male and female players?"

I wonder how many D&W clubs have been caught by the this antiquated procedure? I have had to do it a few times now for Amesbury and the first time I could not find any explanation or instruction on this for Women, when for Men its simple and automatic

2 <u>Huddle Meetings</u>

As lead area rep I will try to drop in on as many huddle meetings as possible – if online! As such if the other huddle leads can let me know when meetings are taking place and share post meeting notes with me so I can format the required council report I would appreciate it. These are only notes and not "minutes" so require no sign off by attendees, just the facilitators recollection of the conversations.

3 – RFU SW staff involvement – or lack thereof

My last few meetings have been without input from RFU despite being assured they would be there and no prior notice to pass out was given. This last meeting I had 2 attendees from RFU who then said they were on the wrong meeting and had to attend the W&G meeting, Surely one could have remained with me as RFU support – which I wanted input from last evening as it happened – and 1 attending the W&G meeting (I was aware of a W&G meeting as Aimee apologised for her non attendance at mine. Scott had stated that Ben would cover my meeting. Either RFU will support D&W or not, but we need to know which

4 - Reg 15: 17 year olds playing Senior Rugby

This arises from recent conversations where the regulation is not clear that if a player had been approved in previous season and requires further approval for this season (not yet 18) BOTH forms are required for the second approval – if already considered OK at club level previously that seems a duplication. Also the smartsheet forms are returned to the parent but not to the submitter it appears. The system is set up by RFU so Julie has no input to that. I am aware John has already raised this at RFU level but feel from a club PoV it would be beneficial to ensure the approval is returned to the submitter as well as whoever else are the standard returns to.

5 – Adult Registration 2024 onwards

Would be great if RFU could get something out on this soon. I have clubs asking why we are still insisting on paper hardcopy forms which carry personal data and risk compromise in 2023 when Age Grade is all on line. There is beginning to get confusing over Affiliated seniors and Registered Seniors/age grade!

Also, I would like to find out what will happen to players not requiring effective registration but need assigning to teams – Non standard formats such as Walking Rugby, Touch, Mixed ability, sevens and 10s teams.

I will be raising this through my own channels but want CB to be aware its becoming an issue both within D&W and outside and the longer its delayed the worse it will get. The secondary point below is for us as CB council to consider though and maybe submit to RFU as a CB point

Now, I don't hold with the panicking worries of some that clubs wont have players if its left to players to re-register, but do wonder if that element is necessary, the important thing is self-registration in the first instance as I am hearing reports of club registering players without the players knowledge – thus ticking the signature seen box on V12 when clearly they hadn't (We had a player start with us found he had been registered with another club without his knowledge – he had played summer sevens with them but that does not require effective registration!!) – this last point could be a disciplinary issue but would never be found positive!

Just wanted to respond with some follow up information to your notes ahead of next week's meeting;

Transfer process

- I have made enquiries on clarification for this and awaiting responses
- RFU SW Support
 - Yes, there was a conflict with 2 D&W events happening on the same night. It was felt that Ben's support was best placed on the W&G Forum for a number of reasons, including opportunity for introduction to them, identification of potential support, supporting the D&W leads with the both the event on the night and future engagement programme. I believe Ben did touch base with you following your huddle to see if there was anything he could support with. In terms of optimum support, the numbers of attending clubs was greater on the W&G call than your huddle.
 - Scott did notify you that he was on annual leave.
- 17 year olds playing Adult rugby
 - To clarify, the club approval is required every season. Without this a player can't play adult rugby at that club. The player approval is only required one time. Once they are approved as an individual that is in place until their 18th birthday, even if it spans two seasons. The system sends approval/decline messages back to:
 For club approval/decline Club Sec or Chair (whichever countersigned the application) and CSO

For player approval/decline – Proposer and Parent (as submitted on the application)

I hope this provides some answers to the queries raised.

- All remaining tickets to be divided between geographic CBs, based on the number of 15 a
 side games played by their clubs. U14 -U18 age grade teams are limited to a maximum
 credit of 16 matches per season in accordance with the RFU Age Grade Code of Practice.

Referees Societies

- Every voting society receives an initial allocation of six tickets.
- All remaining tickets to be divided between voting referee's societies, based on the number of games the society appoints to.
